## 1. Boarding Dates

## 2. Vaccination & Health Requirements

Owner confirms their dog is current and up to date on:

- Rabies
- Distemper (DHPP)
- Leptospirosis
- Bordetella
- Canine Influenza
- Annual fecal test
- Heartworm prevention

Owner agrees to provide proof upon request.

Owner confirms dog is free from fleas, ticks, contagious disease, and has been symptom-free for 48 hours before boarding.

## 3. Illness Policy

If a dog shows signs of:

- Coughing
- Sneezing
- Vomiting
- Diarrhea
- Lethargy
- Contagious illness

Wiggle Butts Doggie Daycare Plus, LLC reserves the right to seek veterinary care at the owner's expense and/or require immediate pickup.

Owner agrees to notify the facility if the dog becomes ill within 7 days after boarding.

---

## 4. Veterinarian Authorization

If medical care is needed, the facility will attempt to contact the owner first. If unreachable, the facility may transport the dog to the owner's listed veterinarian or the nearest available clinic.

Owner authorizes reasonable treatment as recommended by a licensed veterinarian and accepts responsibility for all associated costs.

## 5. Safety & Behavior

Owner confirms their dog:

- Is not aggressive toward people or dogs
- Does not have a history of biting
- Is safe for a home-based boarding environment

If a dog displays unsafe behavior, the facility may require early pickup.

Owner is responsible for all damage caused by their dog, including property damage or injury to other animals.

## 6. Boarding Environment

Owner acknowledges that Wiggle Butts Doggie Daycare Plus, LLC provides:

- Home-based boarding

- Social play with compatible dogs
- Supervised free-roaming time
- Private off-leash exercise in a fully fenced, one+ acre yard with agility equipment

Owner understands that although every safety measure is taken, injury risk (scratches, sprains, minor play injuries) may occur in any social dog environment.

## 7. Personal Items

Owner may bring toys, blankets, or belongings but understands items may be damaged or lost. The facility is not responsible for replacing personal items.

## 8. Payment & Deposits

- Payment is due at pickup unless stated otherwise.
- Deposits may be required for holiday or peak-season bookings.
- Deposits are non-refundable unless the facility cancels.

Late pickups may incur additional charges.

## 9. Photos & Media Consent

Owner grants permission for Wiggle Butts Doggie Daycare Plus, LLC to use photos or videos of their dog for business use (social media, website, advertising).
